

# Bousquet Mountain Concert Terms & Conditions

Bring a blanket and lawn chairs and enjoy this outdoor concert! There will be very limited patio seating available on a first-come, first-served basis. Food and beverage options will be provided by Bousquet Mountain for both indoor dining and outdoor snacks. Every event at Bousquet Mountain is designed to be family-friendly and welcoming to all-age audiences. No outside food, beverages, or pets are allowed. Water in sealed plastic bottles or empty personal bottles is permitted.

ALL EVENTS AT BOUSQUET ARE RAIN OR SHINE. Refunds will not be issued due to inclement weather unless the event is fully canceled. In such cases, Venue may elect to cancel, delay, or reschedule the event.

ALL SALES ARE FINAL. Tickets should be treated like cash. The Venue is not responsible for any loss or inconvenience caused by unauthorized ticket duplication. If duplicate copies are presented, the Venue reserves the right to deny entry to all parties involved.

For safety, all attendees and their belongings may be subject to search upon entry. Refusal to consent to a search will result in denial of entry.

IMPORTANT: THIS TICKET IS A REVOCABLE LICENSE. The Holder voluntarily assumes all risks of illness, injury, or death, including but not limited to COVID-19 or other communicable diseases. No reentry is permitted once admitted.

Weapons, illegal drugs, and all outside food or drinks are prohibited. The venue is entirely smoke-free, including the use of electronic smoking devices and vaporizers. Substances regulated under the Controlled Substances Act, even for medical use, are not allowed.

Unauthorized audio or video recording, flash photography, or use of professional cameras is not permitted. The Holder agrees not to transmit or distribute any recordings or images of the event.

Violation of these terms may result in denial of entry or ejection without refund. Venue reserves the right to remove anyone deemed disorderly, intoxicated, or non-compliant with security or health policies.

Tickets may not be resold above face value. Unauthorized resale or reproduction is grounds for cancellation without refund.

By attending, the Holder grants the Venue and its affiliates the right to use their image and likeness in any media or promotional material without additional consent or compensation.

The Holder assumes all risks related to weather and Force Majeure events (e.g., acts of God, government regulations, power outages). Event details, including date and performers, are subject to change.

If the Event is rescheduled, tickets may be honored for the new date. If canceled, the Holder may receive a refund, credit, or donation option for the face value, taxes, and facility fees. Refunds may not include third-party ticketing fees and will not be issued for tickets purchased from unauthorized resellers.

The Venue disclaims all liability for indirect, incidental, or consequential damages. Remedies are limited to refunds of face value, applicable taxes, and facility fees if eligible. The Venue's aggregate liability shall not exceed this amount. Attorneys' fees are not recoverable.
